



CANADA STUDY VISA PROCESS 2023

Select a program

One of the most important steps in Canada Study Visa Process 2023 is to select a program to study in Canada that is related to your previous study. This means that the program you wish to study in Canada should be relevant. The program you choose to study in Canada should be a logical progression of your previous academic and work experience history.



In case, the case officer feels that this is not in alignment with your previous study, then he/she may not be satisfied with your purpose of visit in Canada and consequently might refuse the study in Canada visa application on these grounds. Another requirement, in this case, is that international students must meet the eligibility criteria, which means that they must have academic as well as English language ability to complete study in Canada.

International students can contact West Highlander, the best Canada study visa consultant in Chandigarh, to solve queries such as when should I apply for September intake in Canada 2023? When should I start applying for fall 2023 Canada? Applicants must note that it is advised to apply for Canada study visa at least 3 months before the intake.

APPLY FOR OFFER LETTER

After study in Canada aspirants choose a relevant program, they can apply for the offer letter in the college/university in Canada. International students must send a complete admission application package to the college. Along with the application for the offer letter, the applicants must send the following documents.

- Previous academic qualification certificates
- IELTS/ PTE score evidence
- Your identity proof in the form of your passport copy
- Statement of purpose (SOP)
- Previous work experience documents (Appointment and experience letter)

Applicants might have to pay the application fee associated at this stage, however some colleges and universities in Canada give waiver off the application fee to the international students. Applicants are advised to check the specific college or university they select to study in Canada. Before applying for the offer letter to study in Canada, students must also check whether their chosen intake has seats available for international students.



PAY TUITION FEES

After getting the offer letter for the chosen program to study in Canada, the next step in Canada Study Visa Process 2023 is to pay the tuition fees for the program. This will ensure the students have a secure seat in the program. Another thing the applicants need to keep in mind is to pay the tuition fees before the offer letter expires. After paying the fees for the program, the students will get an official receipt from the college. This receipt is mandatory when applying for Canada student visa.






OPEN GIC ACCOUNT

The next step in the Canada Study Visa Process 2023 is to open the GIC account. The applicants can choose to do this after receiving their offer letter to study in Canada. The purpose of opening the GIC account is to show that the applicants have the funds to meet the cost of living in Canada. International students must open a GIC account in Canada to pay their cost of living in this account.

GIC means guaranteed income certificate and it is a great way to prove that the students have a cost of living to support themselves while they study in Canada. After opening the GIC account, the applicants should transfer an amount of CAD \$10,000. Post submitting this amount, the students will get the GIC certificate, which is mandatory to be attached to their Canada study visa application. MEDICAL TESTS

Canada Study Visa Process 2023 also requires the students to have their medical done. The applicants must book an appointment with a doctor who is on the list of panel physicians. This part of the Canada Study Visa Process 2023 needs to be completed before submitting the file. The applicants must also have their identity proof in the form of their passport, before they go for their medical exam.



SUBMIT APPLICATION

After gathering all the documents, the last step in the Canada Study Visa Process 2023 is to submit the Canada study visa application. The applicants need to pay the visa fee before submitting the file, which is done online.

ADMISSION & VISA REQUIREMENTS

ACADEMIC ENTRY REQUIREMENTS AFTER 12TH

For the most part academic entry requirements for study in Canada after 12th include having good percentage of marks in 12th class studies. Another important requirement is that the students must have studied mathematics in their previous education, however, it is not compulsory in all programs and international students can find programs where mathematics is not a requirement.

MINIMUM PERCENTAGE REQUIRED FOR CANADA AFTER GRADUATION

The minimum percentage required for Canada after graduation is not fixed and it varies depending on the type of program you want to study in Canada and also the college or university you have chosen to study in Canada. International students must have good percentage in their graduation studies to get admission in good colleges or universities in Canada. The minimum percentage required for Canada after graduation approximately 55-60%, applicants must note that this is not applicable to all programs, but is enough for some good programs to study in Canada after graduation.

HOW MUCH IELTS SCORE REQUIRED FOR CANADA STUDENT VISA?

This is one of the most important requirements to study in Canada for international students whose first language is not English. The IELTS score required for Canada student visa is different for all programs, it depends on the level of the program. International students usually have the question: How much IELTS score required for Canada student visa?

In case the students opt to do Diplomas programs in Canada, associate degrees in Canada or Advanced Diplomas in Canada, then the IELTS band requirement is 6.0 overall bands, with minimum 5.5 bands in all the four modules Reading, Writing, Listening, and Speaking.

However, the IELTS score required for Canada student visa in case of bachelor's degree programs in Canada, the overall IELTS band score requirement is 6.5 bands with at least 6.0 bands in each of the modules. International students can also have equivalent scores in PTE or TOEFL exams to meet the admission and visa requirements to study in Canada 2023.



DOCUMENTS REQUIRED FOR CANADA STUDY VISA

- All previous Academic documents.
- Passport copies.
- Proof you have funds to study in Canada.

To prove that you have met the condition of GIC you must attach a GIC certificate received from the bank in Canada. Applicants must take care that they get a GIC from a bank which meets the requirements for Student direct Stream.

Students may attach their IELTS score card with their study in Canada application to prove that they meet the English language ability condition under the SDS stream.

To meet the medical examination condition the students may attach the medical examination receipt received from the IRCC approved doctor

CANADA STUDY VISA FULL COST FROM INDIA

Following are the major cost associated with your Study in Canada application

- Admission application cost
- Tuition fee cost
- GIC cost
- Health examination cost
- Canada student Visa embassy fee cost
- Passport visa stamping cost
- Airfare cost for travel to Canada

ADMISSION APPLICATION COST

Pay for admission application – Send admission application to college for offer letter. This is the first step of your study in Canada application. International students need to pay an application fee at this stage. The fee may vary depending on College or university you wish to do the course. It is not a very big amount. It may range from Canadian dollars 75 to Canadian dollars 150. Your Canada study visa consultant can guide you about this.

TUITION FEE COST

Pay for tuition fee- Get letter of Acceptance that is LOA from the college or University. This is the second cost associated with your Study in Canada application. Students after getting the offer letter need to pay for the tuition fee. The average tuition fee annually is as below.

- Diplomas about Canadian dollars 15000 per year
- Bachelors degree about Canadian dollars 20000 per year
- Associate degrees about Canadian dollars 15000 per year
- Graduate certificates about 18000 Canadian dollars per year
- Masters degree about Canadian dollars 22000 per year



Students may have the option to pay for 6 months of tuition fee. It is highly recommended that the students pay tuition fee deposit of full one year. If the Canada student visa application falls under SDS category then payment of one year of tuition fees is compulsory. SDS processing of your Canada study visa application has got its own advantages.

GIC CERTIFICATE COST

Pay for GIC for your Canada study visa. As a part of their Canada student visa application international applicants are required to have their cost of living for their stay in Canada. GIC is an excellent way to prove that you have the required finances for your stay in Canada while on study visa. The requirement is to have a minimum amount of Canadian dollars 10000 in your GIC account





PAY FOR HEALTH EXAMINATION

Health examination is another cost associated with your study in Canada application. Students are required to arrange their medical examination from the authorised doctors. Students need to book an appointment .The payment may depend on the doctor you are availing the services from. In India it may cost you from 4000 to 5000 Indian rupees.

CANADA STUDY VISA EMBASSY FEE

Once the students have compiled their Canada student visa documentation they need to submit their application. At this stage the students are required to pay embassy fee which is currently Canadian dollars 150

BIOMETRICS

The Biometrics is to be given by the applicants. The fee is Canadian dollars 85. This is paid along with the embassy fees.


VISA STAMPING FEE

Once the students have got the approval of the application they need to submit for visa stamping. At this stage the students need to pay the fees which is about Indian rupee 1800.

PAY FOR TRAVEL TO CANADA

Travelling cost is another expense. It would depend on the time you are travelling as well as the airline. Students need to check the current ticket rates for this.





CANADA STUDY VISA WITH SPOUSE

Requirements the main Canada study visa applicants need to meet

There are 2 basic requirements the main student visa applicant needs to meet. These are as below

The first and foremost requirement is that your application for study in Canada must fall under SDS that is student direct stream. This is the basic condition applicants are required to meet if they would like to submit the Canada open work permit visa file along with the student visa file.


The second requirement is that the course the main Canada student visa applicant is enrolled must have post graduation work permit rights that is post study work visa after the successful completion of the study program in Canada. If the course does not have post study work visa associated with it then despite the main student visa applicant being eligible for SDS that is student direct stream processing the Canada student dependent applicant will not be able to apply for Open work visa either with the main applicant or after the main applicant has successfully received the visa to study in Canada

Requirements both the applicants that is Canada student visa applicant and Canada student dependent visa applicant need to meet

One of the requirements both the applicants need to meet is of being in a genuine relationship. The student dependent visa application is granted based on your relationship. You must meet the requirements of being legally married and the marriage being done with the intention of maintaining it on a long term basis. Failing to meet this requirement may have negative impact on the application

Requirement the Canada open work visa applicant that is the dependent spouse needs to meet

The Canada student spouse visa applicant must have enough funds to support the stay while in Canada. This is one of the requirements of Canada open work permit visa. These funds must be available for your stay in Canada. These must held in your bank account over a period of time. You must have good level of establishment in your home country.
